

# **IDT ASSESSMENT AND LITIGATION**

BDO in India 2023



The Indian indirect tax laws typically require taxpayers to self-assess the tax liability and discharge the same in the prescribed manner. Certain indirect tax laws prescribe the methodology with respect to the declaration of specified details of supply/ procurements in the returns while paying taxes. As the details required under the law are submitted by the taxpayer, the tax authority may conduct a scrutiny/ assessment/ audit to validate the disclosures and the taxes paid. It involves the examination of records, returns and other documents maintained or furnished by the taxpayer under the law to ascertain the correctness of details declared including taxable turnover, taxes paid, refund claimed, input tax credit availed, etc., and to assess compliance with the provisions of the tax law. The assessment/ audit is carried out as per the timelines prescribed under the respective tax law.

Under the erstwhile VAT law and the current GST law, state-level assessments are undertaken by the Authorities. The assessment of Service Tax was centralised, and Customs is generally on the basis of the port of import.

### WHY BUSINESSES NEED TO BE ASSESSMENT-READY

#### IMPORTANCE

- Positions adopted at the time of implementation may have evolved with newer precedents and policy changes.
  With laws and positions getting crystalised, revisits and corrective actions become inevitable.
- The law has been evolving and clarifications were not received on several questions.
- Business processes and industry practices may have undergone change with corresponding changes in tax consequences which may require correction.

#### BENEFITS

- All documents, records and reconciliations will be ready for the assessments.
- The probability of unexpected questions surfacing during the assessments is reduced.
- Since corrective actions are taken early on, there is a possibility of reducing the exposure on account of penalties and/or interest.
- Early indication of non-compliance for timely corrective action by vendors, for ITC availment, wherever possible.
- Timely action may optimise tax benefits which may not have been evaluated or actioned.

- Collation of invoices, bills of supplies, e-way bills, return filing due dates, sales and purchase registers, GST monthly and annual returns and tax payment challans.
- Review of sample invoices, agreements and documents.
- Reconciliations and mapping including revenue, output taxes paid and input tax credit availed as per Form GSTR-3B vis-à-vis input tax available in form GSTR-2A/B.
- Keeping the assessment file/ e-data ready.
- Representation before the tax authorities and follow-up to close the assessment timely.


# SMART VIRTUAL AGENT (BOT)
